

## **CURRENT Topics**

- Salary Over the Cap Budgeting and Payroll Allocations (presentation)
- Update to NIH's Data Management and Sharing Plan budgeting guidance NOT-OD-23-161
  - "Effective for applications submitted for due dates on or after October 5, 2023, NIH will no longer require the use of the single DMS cost line item. NIH recognizes that DMS costs may be requested in many cost categories. Therefore, in line with our standard budget instructions, DMS costs must be requested in the appropriate cost category, e.g., personnel, equipment, supplies, and other expenses..."
  - "...NIH will require applicants to specify estimated DMS cost details within the "Budget Justification" attachment ..."
- Distinction between DSMP and DMSP:
  - Data Safety and Monitoring Plan (DSMP) specific to human subjects studies that require oversight, usually from a Data Safety and Monitoring Board (DSMB)
  - Data Management and Sharing Plan (DMSP) related to the dissemination of scientific data for all types of awards under the new policy effective in January of this year - NOT-OD-21-013
  - Both may have distinct costs in the budget
- Distinction between DMSP and Resource Sharing Plan (RSP):
  - DMSP address data management and sharing and genomic data sharing, when applicable
  - RSP address other applicable NIH-wide sharing policies (e.g., Model Organism Sharing Policy, Research Tools Policy)

#### **TIPS and Reminders**

- Please use the Quick Review Guides (QRGs) when preparing AMRs to help speed up processing times!
- QRG for Grant Managers to submit Budget Amendments in Workday
  - Rebudgeting funds between categories within a single GR
  - Not for moving funds between GRs or creating a new GR line [this should still be requested via AMR]
- Reminder for Resubmission proposals in Huron: check the Funding Opportunity Package in the Funding Proposal the system will pull in the previous package, which may be an outdated or incorrect version
