

University of Virginia Medical Center Hematology and Oncology Physician Coverage (HO-PC) Service

Eligibility:

Resident/fellows holding J1 visas under sponsorship of the ECFMG may NOT moonlight.

The following documents need to be sent to Kim Anderson (Division of Hematology and Oncology):

- UVAHS Moonlighting Request Form signed by your program director and GME office.
- Signed Hematology and Oncology Physician Coverage (HO-PC) Agreement.
- Copy of permanent Virginia full medical license and current DEA.
- Copy of photo ID such as driver license or passport.
- Copy of Internal Medicine Board Certification, if applicable.
- Updated Curriculum Vitae.

Requirements:

- Physicians should be committed to do a minimum of two-three 12 hour shifts a month.
- Trainee physicians are not allowed to take more frequent shifts than every fourth day counting for overnight shifts on other services including IRPA.
- Total clinical responsibilities (Residency or fellowship plus moonlighting) should do not exceed 80 hours per week when averaged over a four week period.
- Reserved shift cannot be cancelled in less than week period and Clinician will be required to find coverage for their shifts; Failure to do so will subject the clinician for probation for the first time and to service termination in the second time this occurs.
- Moonlighting must not interfere with the trainee's performance of patient care or educational responsibilities on any rotation during residency or fellowship training.
- Maintain proper documentation of care provided in accordance with University of Virginia Medical center policies.
- HO-PC Clinicians are not required to obtain additional professional liability coverage.

Scope of work:

HO-PC are expected to stay overnight in the main hospital to cover for the medical oncology, malignant hematology/stem cell transplant, and chemotherapy services; this includes:

1. Inpatient medical care. Coverage of all patients admitted to the medical oncology, malignant hematology/stem cell transplant, and chemotherapy services. There will be a Department of Medicine Internal Medicine Residency intern providing overnight coverage with the HO-PC Clinician.
2. Overnight admissions to the medical oncology, malignant hematology/stem cell transplant, and chemotherapy services.
3. Transfer patients to MICU service if needed.

Hours Requirement:

- All Shifts from 7:30PM to 7:30AM

Compensation:

- Residents
Monday to Friday: \$900 per shift
Weekends and All Major Holidays: \$900 per shift
- Chief Residents, Fellows, Hospitalists, and Faculty
Monday to Friday: \$1000 per shift
Weekends and All Major Holidays: \$1000 per shift

Term:

This agreement can be terminated by the Division of Hematology/Oncology if the HO-PC Clinician violates the terms of this agreement or his/her UVA credentials were terminated for any reason.
