PARTICIP	Participation ID: Assigned by applicant organization to uniquely identify and track participants across sessions.
ENROLL	Enrollment Source: Referral source. <ol style="list-style-type: none"> <li>1. Non PCP health care professional (pharm, dietitian)</li> <li>2. PCP</li> <li>3. Community organ or community health worker</li> <li>4. Self</li> <li>5. Family/Friends</li> <li>6. Employer</li> <li>7. Insurance</li> <li>8. Media</li> <li>9. Other</li> <li>10. Not reported</li> </ol>

GDM	Prediabetes determined by diagnosis of GDM 1=Yes 2=No
RISKTEST	Prediabetes determined by risk test 1=Yes 2=No
AGE	Participant's age at enrollment.
ETHNIC	Participant's ethnicity. Pt self identifies. 1=Yes 2=No 9= not reported
AIAN	American Indian or Alaska native 1=Yes 2=No or if not reported in all 5 categories
ASIAN	Asian or Asian American 1=Yes 2=No or if not reported in all 5 categories
BLACK	Black or African American 1=Yes 2=No or if not reported in all 5 categories

SEX	Participant's sex 1=Male 2=Female
HEIGHT	Participant's height in inches
EDU	Participant's highest achieved education level 1= Less than grade 12 (no GED or HS diploma) 2=Grade 12 (HS diploma or GED ) 3=Some College (103 years) 4=College (4 or more years & college graduate) 9 = not reported
DMODE	Delivery Mode 1= In-person 2=Online 3= Distance learning
SESSID	Session ID. Provide specific session attended as follows: 1 to 26 = Core session or make up session in month 1-6 99 = Core maintenance or make up 88= Ongoing maintenance or make up (for Medicare DPP)
SESSTYPE	Session Type. C = Core session. Any session delivered in months 1-6 even if pulled from months 7-12 of curriculum CM = Core maintenance session. Any session delivered in mos. 7-12, even if pulled from mons 1-6. OM = Ongoing maintenance (for MDPP) MU = Make up session
DATE	Session Date. Recorded as mm/dd/yyyy
WEIGHT	Participants measured weight. MDPP cannot use self-reported wt 70 – 997 999 = not recorded
PA	Participant's physical activity minutes 0 = when participant says that no PA was done that week 1-997 = minutes of actual PA 997- If number of PA minutes exceeds 997 minutes 999 = used during initial period when no PA minutes recorded
